5. Annual General Meeting (AGM)

It's time to schedule a date for NPS' Annual General Meeting.

- ! A date must be chosen before March 13, 2025 so notices can be printed in the March 19, 2025 and the April 2, 2025 issues of Nexus Newspaper.
- ! The AGM needs to take place after April 1, 2025 and have a minimum of 10 people in attendance.
 - ! Greg recommends the week of April 7, 2025 to April 11, 2025.

A preliminary date and time of Thursday, April 10 at 4:00 p.m. was suggested by Sam over email on March 11.

- ! Jaxson has indicated that he could attend on this date and time.
- ! Max has indicated that they can attend on this date and time, but will have to leave by 5:00 p.m.

The date and time of Thursday, April 10 at 4:00 p.m was published in Nexus Newspaper after the March 13 board meeting was cancelled.

- ! NPS has an obligation to give a minimum of 14 days notice in Nexus Newspaper for an AGM.
 - ! This is outlined in rule 11.2 in the Nexus Publishing Society Constitution and Bylaws.

6. Social Media

Greg has raised the possibility of a volunteer outreach position that handles social media and student engagement.

- ! This was discussed briefly in the September 2, 2024 Meeting Minutes: September, 2 2024 Nexus Meeting Minutes, but was put on the backburner to prioritize the October 2024 referendum.
- ! Nexus Newspaper currently has a TikTok account run by Ray, a volunteer.

Sam will reach out to Greg over email to discuss next steps.

7. CCSS Grant Proposal

Greg and Sam will be presenting a proposal to CCSS to increase Nexus' operating grant at the March 24, 2025 CCSS board meeting. The proposal seeks an increase of up to \$30,000 to the grant's 2008/09 base amount of \$65,018.16, which is adjusted annually for inflation.

The grant proposal is available in the Board Member Documents folder on the NPS Google Drive.

According to Terence, the CCSS' questions focus on possible qualitative impacts the proposed funding increase will have on Nexus Newspaper. They'd also like to hear about ways we plan to increase student engagement and discuss possible alternatives; Terence mentioned decreasing the number of mandated issues per year from 18.
